# Mission Growth (Justice)

Margie Neugebauer

"Spiritual Formation: Following the Movements of the Spirit" by Henri Nouwen

Nouwen was a Dutch Catholic priest, professor, writer and theologian. His interests were rooted primarily in psychology, pastoral ministry, spirituality, social justice and community. He wrote 39 books on the spiritual life.

"Spiritual formation prepares us for life in which we move away from our fears, compulsions, resentments, and sorrows, to serve with joy and courage in the world, even when this leads us to places we would rather not go. Spiritual formation helps us to see the face of God in the midst of a hardened world and in our own heart. This freedom helps us to use our skills and our very lives to make that face visible to all who live in bondage and fear."

"Spirituality asks us to empty our mind so we can open our heart to receive life as a gift to be lived."

Nouwen identifies five practices that seem of special importance in spiritual formation: reflection,

lectio divina, silence, community, service

**Reflection** is understanding that the spiritual life finds its basis in the human condition; it isn't lived outside, before, after, or beyond our everyday existence.

**Lectio divina** refers primarily to the sacred or devotional reading of the Bible and then openness to what the Spirit is saying to us in the present moment. Here is where we can see how God's story and our story intersect.

**Silence**—without silence the Word of God cannot bear fruit. One of the most depressing aspects of contemporary life is the almost complete absence of silence. The mystics all agree that silence is the royal road to spiritual formation.

**Community**—spiritual formation requires taking not only the inward journey to the heart, but also the outward journey from the heart to community and ministry. Christian spirituality not only flows from community but creates community.

**Service**—to serve means to minister, to love and care for others, and to recognize in them the heart of God. A true disciple of Jesus will always go to where people are feeling weak, broken, sick, in pain, poor, lonely, forgotten, anxious, and lost. Thus, spiritual formation means ongoing formation of the heart, in community life, expressed in service to the world.

# Lutheran Planned Giving of South Dakota

Are you blessed to have celebrated your 70<sup>th</sup> birthday? Do you have retirement accounts that now generate something called **Required Minimum Distributions (RMD's)**? Are you writing checks to support your church and other non-profit ministries? What if you could avoid the income tax bill that comes with those RMD's and still be generous?

With the new tax laws enacted earlier this year, increasing the standard deduction to \$12,000 for a single person and \$24,000 for a couple, most of us will not be able to deduct charitable contributions.

Instead of making a donation from your

checking account, call your adviser and request that all or a portion of your RMD be sent directly to the church and/or ministries of your choice. You'll satisfy the IRS requirements and make a difference with your gifts, but will not be required to pay the income tax that would otherwise be due!

Additionally, a Qualified Charitable Distribution reduces your total income for the year, which could in turn reduce or eliminate extra Medicare premiums deducted from your Social Security check because you would have otherwise exceeded income limits.

This strategy isn't limited by the amount of your annual RMD – the IRS allows a charitable distribution of up to \$100,000/year. If generosity is a part of your plan, make sure that it all goes to ministry. Call me if you have questions or would like to know more.....because you want your life to make a difference.

# Prison Congregations of America

"It's Not About You"

Two important lessons I've learned in this work is 1) Plan, but be patient, and 2) It's not about you. As my long-suffering husband will attest, I am a list maker. I plan and I envision. This works OK for grocery shopping, but not so much for planting prison congregations. On many occasions, I thought everything was in order, when one of the many variables suddenly was off. Maybe the denomination had lost heart, or maybe the prison had a new warden who was not interested in new programming. Maybe it's a lockdown and the prison worship service gets cancelled.

Case in point: For almost two years I have been in conversation with some clergy leaders of the United Methodist Church in Florida. They had heard about the PCA Model and very much wanted to

sponsor a prison congregation in their area. They had the will, the support and the funds. All they needed was a prison that would let us in.

For two years we talked and strategized, but except for a couple of short conversations, we had no contact, certainly no positive contact with the prison. Finally, we started talking about exploring the possibility of some sort of ministry in a youth detention center, thinking that might be easier. Before I started contacting administrators in the youth facilities, I made one more call to the adult prison. Someone answered and referred me to their newly hired program manager. This man immediately saw the value of what we were offering and convinced his leadership team to give us a try. It appears that we will have a pastor in place by early next year! Everyone is joyfully on board!

I hear God say – this time as so many times previously: "Plan, but be patient, because at the end of the day, it's not about you and your plans. It's all about me."

# **How You helped SD Win its Supreme Court Case**

For over 14 years you have been paying higher tax on your groceries so that South Dakota could win its tax case in the Supreme Court this year.

Why? The preparation for the state to collect sales tax on online sales caused a significant hike in the tax on food, **only on food**.

How? Before 2003, SD cities were limited to 1% tax on food. Then, tax "streamlining" rules were needed in order to tax online sales. The new rules allowed each city only one sales tax rate, even though the rules allowed the state itself to have a lower rate on food, even zero tax.

Thus, cities' food taxes rose from 1% to 2% in

most South Dakota cities, rather than lowering tax on other things to match the 1% on food. (Some cities had not been taxing food at all, including Rapid City, Spearfish, Mitchell, Pierre. They were forced to start taxing groceries.)

Back in 2003, some legislators said they would cut the food tax when the state finally receives tax from online sales. Now this revenue will be coming.

Bread for the World-South Dakota is calling on the next legislature to recognize the contribution made by grocery shoppers to the Supreme Court success and hunger in South Dakota and turn next tax cut into a cut in the food tax. (With cities still allowed only one tax rate, a food tax cut would need to be a reduction in the state's portion of the sales tax.)

Rather than current law taking tenths of percents off the general rate, for the same money, the state legislature could choose to take whole percents off food. We can ask candidates for state legislature to choose to cut the food tax.
