Dear South Dakota Synod,

Friends in Christ,

Grace and peace to you in the name of the Father,

the Son, and the Holy Spirit! – Your ministry partners of the South Dakota Synod and I are looking forward to connecting with you during this year's assembly. The partners, planning team, staff, and volunteers of Our Savior's Lutheran Church are ready to foster connections across the church in fresh and proven ways. In preparation for your attendance and participation in this year's assembly, I will offer a snapshot of Synod ministry.

Expanding Our Reach

In the Spring of 2023, we applied for \$1,137,384 from Lilly Endowment Inc. through its Thriving Congregations Initiative. to grow our mission of "Journeying together in Christ" more boldly. In November 2023 the foundation informed us that we were awarded the amount we had applied for.

Since then, Pastor Kari Webb has been called unto Synod staff as the Director for Digital Community and E-Learning to develop a digital space for gathering and education with not only South Dakota but the whole church in mind. The vision for the Learning Management System (LMS) is that this digital gathering space will help us to grow closer together as the South Dakota Synod and the wider church through cohorts, resource sharing, and relationship building.

The grant also offers additional resources to expand our focus on rural emergent ministries, whether it is the rural liaison position or our rural emergent experience for seminarians in collaboration with Wartburg Seminary.

Expanding God's Kingdom

With generous support from our partners at the churchwide organization and locally, Pastor Sawyer Vanden Heuvel launched the synod's newest Synod Authorized Worshipping Community (SAWC) in Sioux Falls, Shepherd's Table. It is an intentional community for those who feel abandoned and marginalized by traditional worshipping communities. Shepherd's Table gathers monthly for dinner church at the Prism Center in Sioux Falls. I encourage you to speak with Pastor Vanden Heuvel during the assembly to hear how you can connect with and participate in Shepherd's Table.

We continue to have robust conversations concerning a mission start in Box Elder. Pastor Carla Nelson finished a successful exploration to investigate the viability and need of planting a faith community there. The results leave no doubt about the need. The next step is to seek and secure financial sustainability through building intentional relationships with donors, community, conference and individual partners. If you are interested in learning more and are committed to developing a worshiping community in Box Elder, please stop and talk to Pastor Jonathan Vehar at the assembly.



Expanding Our Vision

Traveling to Cameroon in October 2023 for the Centennial of the Sudan Mission was an exhaustingly holy experience. It is a tradition in Cameroon to commission the printing of fabric for special occasions. It will be gifted to visitors and friends and offered for sale. Our group was awarded many yards of fabric, which the quilters of Our Savior's Lutheran Church in Sioux Falls are graciously turning into everyday items you can purchase at the assembly. All proceeds will be directed to fund well-established ministries in Cameroon, such as the roof project, the seminary, and the Lutheran Hospital.

Steps are being taken by the synod and the churchwide organization in partnership with the Lutheran Church in Nicaragua to call our missionaries since Soliette's transition to Mexico. Once the missionaries are in place, we will begin sending teaching delegations to Nicaragua. Thank you to all of you who have sent tributes about Bishop Victoria to the synod office. The video tribute will air for the first time publicly at the assembly, be made available for congregational use following the assembly, and be sent to the Lutheran Church in Nicaragua. May God bless her legacy!

I continue to be filled with a deep sense of gratitude as you entrust me to serve as the Bishop of the South Dakota Synod.

Report of Rev. Renee Splichal Larson Associate to the Bishop South Dakota Synod Assembly, 2024

Dear SD Synod of the ELCA,

"...remember, I am with you always, to the end of the age."

- Jesus in Matthew 28.20b



The promise we can trust, no matter what, is the promise from Jesus to be with us always. Whether we experience a bountiful harvest or barren fields, a death or a birth, joy or sorrow, and anything in between, Christ is with you and with me. This Good News matters. It sustains us in times of uncertainty. We trust that Christ has died and risen from the grave for YOU! Christ has given you and your congregation the Holy Spirit of God, so that you may witness to Christ crucified and raised, so that you may be a dwelling place for God's love, mercy, forgiveness, and grace.

I have learned a great deal these last 4-5 years serving as an associate to the bishop in the SD Synod, especially when it comes to congregations in a time of transition. Here are 3 things I have learned:

- 3. Times of transition are part of the normal life of every congregation.

Naturally, anxiety rises when congregations don't know who their next pastor (or deacon!) will be, or how long the call process might take, or whether or not they can "afford" their own full-time pastor anymore. As people of faith, when we worry about what may or may not happen, we are called turn back towards God, our source of life; and remember, Christ is with us always, to the end of the age.

I am reminded about these things I have learned when reflecting back on a given year: Ministry Site Studies conducted, letters of call extended, people preparing for ordained ministry entering their first call, formation of parishes or new partnerships in ministry, Synod Authorized and lay ministers being raised up in local contexts to serve in new ways, tens of thousands of dollars given to aid people in seminary and reduce debt, creative ministry endeavors, and conception of new ministries. The SD Synod "2023 Ministry Celebration" sheet is a testament to God's work in and through all of us together. If you haven't seen it yet, take a look for the details of all the ministry we can celebrate in 2023!

I am grateful and humbled to serve as one of the associates in the SD Synod, to our dedicated, gifted Bishop, who is a person of prayer and deep faith in Jesus. I look forward to gathering as the body of Christ at the 2024 Synod Assembly, where we will be strengthened through the Gospel, and sent back out to minister and witness wherever we are planted.

2023 MINISTRY CELEBRATION



Our Synod's vision of Journeying Together in Christ has continued to focus our work. We invite you to take a few moments to review the list below which celebrates some of the ministry we shared together in 2023. Journeying together in Christ as the South Dakota Synod, in 2023 we:

- Applied for and received a grant of **\$1,137,384** from Lilly Endowment Inc. through its Thriving Congregations Initiative for new initiatives that are not included the Synod's Mission Plan. Please reach out to Synod Staff for **more information**!
- Completed explorations for two new potential church plants, with plans to start a worshiping community in **Box Elder** and **Shepherd's Table in Sioux Falls**.
- Walked with the **40** people in various stages of **Candidacy** and have **4** new entrance interviews scheduled in 2024!
- Received **3 new first call candidates**.
- Completed 23 Ministry Site Studies and extended 28 calls!
- Ensured that nearly every congregation has a called pastor, interim pastor, Synod Authorized Minister, or lay leader to care for God's people (thank you to all of you who are helping out with area congregations and filling in!).
- Distributed **\$77,137** to date through the Seminary Debt Reduction Program.
- Granted **\$123,000** in scholarship funds to seminary students, **\$11,400** in internship site assistance, and **\$82,990** to Luther and Wartburg Seminaries, for a total of **\$217,390** in support of seminary education.
- Created a **pilot rural J-term** program with Wartburg Theological Seminary, which will begin in January 2024.
- Received **\$113,635** in grants from ELCA Christian Community & Leadership.
- Held a **Synod Assembly**, where we gathered again as a community to conduct the business of the synod.
- Hosted **Spring** and **Fall Theological Conferences**, where we continued to support the continuing education of our Rostered Ministers either online or in-person.
- Supported the congregations and ministries of the synod through **visits** by synod staff, both **digital** and in-person.
- Hosted a "Lay Leader Night" to support congregational lay leaders and supported rostered leaders with regular inperson and virtual meetings, such as monthly rostered minister virtual check-ins, Synodically Authorized Minister, Senior Pastor, and Interim Pastor check-ins, and a First Call and Senior Pastor Retreat.
- Pr. Alan Blankenfeld, Synod **Rural Ministry Liaison** continued to journey with our rural ministry sites. In the past year, Pr. Alan has worked directly with **34 communities and congregations in transition**.
- Continued the work of the Rural Ministry Table, which is currently working on **Small Town and Rural (STAR) grants**, grants funded by the generous donations to rural ministry in the Synod.
- Partnered with **Bergen Lutheran** to hold a **Threshing Bee** which resulted in gifts of **\$51,324** to support rural ministry in South Dakota.

Thank you for all the ways you have supported the ministry of the South Dakota Synod this past year! God has called us to be the body of Christ together, and this is an active and healthy body. We look for wardet occontinuing our journey with you in 2024 and beyond!

Preliminary Report

Report of Rev. Jonathan Vehar Director of Evangelical Mission Associate to the Bishop South Dakota Synod Assembly, 2024

It's been a little over six months since starting this role as the Director of Evangelical Mission and Associate to the Bishop, and it's a regular



occurrence to be asked how things are going. Sometimes, it's small talk, others genuine interest, but often confusion about what it is that I even do. The standard answer goes a little like this, "It's all the things I expected it to be. I drive around a lot. Fill out lots of paperwork. Sometimes people are excited to see me, and other times not so much." The filling out of paperwork normally draws a laugh, as intended, even if true.

There has been little to surprise me in the daily tasks. There is lots of driving with nearly 200 congregations throughout South Dakota. I've been to Edgemont in the Southwest, Vermillion in the South East, Bison in the Northwest, New Effington in the Northeast, and lots of places in between. It's not exactly the four corners of the state, but I've gotten pretty close. One of the aspects I've enjoyed the most is worshiping in so many different places and styles, from dancing up my offering at First Lutheran African Ministry to a stringed orchestra at First Lutheran, Sioux Falls. From worshiping with the three-point Prairie Fellowship Parish of American, Rosebud, and Indian Creek Lutheran churches, each with the same green hymnal and same laminated order of worship, but unique in so many other ways. From what felt like a homecoming at Spirit of Hope in Scotland and the under-housed at Church on the Street to the 20ish other houses of worship I joined in giving thanks to God. These last six months have been holy time.

But holy time isn't just found in worship, I see it also in the times of dreaming, strategic planning, lamenting, and praying for guidance and wisdom in where God is calling us in the future.

Speaking of the future, there are a few things in the works. 1) A stewardship strategy that seeks to assist any and all congregations wanting to dig a little deeper into responding to the abundant provisions of God. 2) A media tool kit for Neighbors in Solitary partners to help tell the story of what we do together. 3) Next steps for a new start congregation in Box Elder, SD. These are a few of the bigger ideas that we are responding to together.

On another note, one of the unique roles of the DEM is the connection to the churchwide organization. This is where a lot of the paperwork comes in, but this isn't a complaint, it is one way of walking together. The support we receive from the

churchwide organization, not only in grant dollars, but in sharing ideas, resources, and expertise, is immeasurable. There is much that happens behind the scenes that allows the ministries in South Dakota, and especially our mission developers, to focus on the task of sharing the good news of Jesus. That is, after all, why we are joined together to proclaim the saving word of Jesus to the world. I couldn't imagine trying to do this alone.

In closing, what is worth remembering the most is that there is much for which we can give thanks. For the 200 congregations across the synod, each worships and proclaims Jesus, even if it looks a little different from place to place. I give particular thanks to the rest of the Synod Staff, who are cherished colleagues in this work. To the pastors and deacons when we dream, lament, and pray together.

Companion Synod Coordinator Report to the 2024 Synod Assembly

Greetings rostered leaders, synodically authorized ministers, and lay delegates to the 2024 South Dakota Synod Assembly! Below are a few highlights and updates from our companion synods of Nicaragua (ILFE) and Cameroon (EELC).

Nicaragua

As you might have heard, Bishop Victoria of the Lutheran Church in Nicaragua (ILFE) passed away at the end of September. When we received news of her passing, a condolence letter from Bishop Hagmaier on behalf of the Synod was sent, as well as an offer of whatever support we could offer. For now, Pr. Katia Cortez, will serve as President of ILFE, until an election is held in 2025. To honor Bishop Victoria, a scholarship fund has been established started for pastors in Nicaragua by the Companion Synod Committee. Thank you to everyone who submitted video and written remembrances and photos, to share in the tribute video for Bishop Victoria at the 2024 Synod Assembly. A recording of the tribute will be available after the Assembly on the Synod website and social media pages.

Speaking of Synod Assembly, we are thrilled to welcome Pastor Mike Busbey and his wife, Hellen Rios-Carrillo, to our 2024 Synod Assembly. Mike (he/him/his) serves as Regional Representative for Central America and Mexico, and Hellen (she/her/hers) serves as Regional Representative for the Caribbean and Gender Justice. They are based in Costa Rica but relate to companion churches and theological institutions throughout the region. Pastor Mike previously served as a missionary with ILFE and the South Dakota Synod (2011-2015), and is rostered in the South Dakota Synod. Hellen was born and raised in Nicaragua and is a member of the Nicaraguan Lutheran Church of Faith and Hope (ILFE); previously served with the Lutheran World Federation relating to churches in Central America and their ministries centered on women.

Another important update to share is Celeste Evora and Anghy Aragón, two young women from Nicaragua, will be sharing the role of missionary for the South Dakota Synod in Nicaragua. They will begin as soon as the ELCA churchwide office completes the appropriate background check and paperwork.

A final update to be aware of is that Cari Eastman, the chair of the Companion Synod Committee, and I traveled to the Houston area from October 31st to November 3rd for the 2023 Latin America and Caribbean International Companion Synod Consultation. These consultations, held every three years, are a chance for representatives from companion synods in that region, like the South Dakota Synod and ILFE, to meet face to face and have intentional time for fellowship and discernment of future goals for our work together. Cari and I had some wonderful conversations with Pr. Katia about how to strengthen our relationship and some priorities for partnership for the next three years.

If you would like to support our work with ILFE, some priorities identified by Pr. Katia are our Seeds of Hope Program, teacher salaries at their school in Pochocauape, and the Bishop Victoria Memorial Scholarship Fund. We have also recently purchased three motorcycles for ILFE to help rural pastors travel between congregations, so another great way to support the work of ILFE is to donate funds toward fuel and maintenance of those motorcycles.

Cameroon

The big news here is that Bishop Hagmaier and I led a delegation to Cameroon in the first part of October for the centennial celebration of the Lutheran Church in Cameroon (EELC). It was wonderful to meet so many members of the EELC, especially Bishop Baiguele, share time of worship and fellowship, and discuss more about how we can continue to honor and grow our partnership in the future. There were some literal and figurative bumps in the road along the way, but it was a good trip, and our presence there was appreciated and celebrated. Hopefully this will lead to even better communications between us and future delegations travelling there.

The Companion Synod Committee set a goal to raise enough funds to pay for seven roofs (one for each conference) for congregations in Cameroon by the time the delegation from our Synod travelled there for the Centennial celebrations. We didn't quite meet that goal, but I'm pleased that we were able to meet goal by the end of the 2023. Thank you to all of the conferences, congregations, and individuals who contributed to this project!

Church roofs continue to be the number one priority that Bishop Baiguele identified for support from our Synod. Other priorities include the EELC School System, the Garoua Boulai Hospital Poor Fund, and the Lutheran Seminary in Meiganga.

General

Companion Synod Sunday was held on Oct. 1. I was able to be present at Augustana Lutheran to give a temple talk and presentation at their adult forum time about companion synods. I know several congregations did include companion synods in their prayers of the day, and some did take advantage of the materials prepared by the Committee for that Sunday. We are again going to celebrate Companion Synod Sunday on the first Sunday in October of this year (October 6th). Hopefully this will become an annual commemoration and grow to where every congregation in the Synod is celebrating a Companion Synod Sunday in the future. Please let me know if you would like someone from our Companion Synod Committee to come to your congregation.

Finally, thank you for all the ways you support our Companion Synod ministry – in prayer, sharing stories, pictures, and videos of the work being done in Nicaragua and Cameroon, and, of course, financially. Together, we are making a big difference in the lives of many and helping to make sure the good news of Jesus Christ is heard!

Fostering mutual trust, respect, and understanding, while addressing the deep poverty that exists on the reservation.

Did you know that a porta-potty can freeze solid? They can, it is one of the many lessons I have learned since I arrived in Pine Ridge. This winter has been much milder than last year. But we had a 14 day stretch below freezing.

Winter is the time when the **Homeless Shelter** is our biggest focus. We are averaging 42 people a night at the overnight shelter and service 70+ people each day at the day shelter. In the period from June to April we served over 13,500 meals to the shelter guests. This number does not include the kid's time meals (80+ per week) nor does it include the food going out the front door during non-shelter days. (During the summer we do not open the day shelter every day.) We average \$4000 a week in food. Recently we opened an account with US Foods. This will relieve some pressure on me to do much of the shopping.

We have been operating the **Homeless Shelter** since November of 2022 and currently, we are using the center as a day shelter. Working with the tribe we were able to reopen the night shelters as a High Barrier shelter only for those that are sober and working to improve their lives. From November thru April, we have operated the low barrier shelter.

The shelter, day and night, is truly making a difference in the lives of the homeless population and has had a ripple effect through the community. We are living out our mission.

Kid's Time continues to be busy. The Job Corp staff and our intern Lessanes stepped up to help lead the program through the holidays. The team is still providing food and activities for the kids. The kids appreciate the meals we provide. In some cases, it is the only hot meal they receive outside of school. The snack packs we provide on Fridays are not only wanted but they are also needed.

We are gearing up for the **Immersion season.** Tony Walking, the Director of Immersions has been working with the groups planning for this year. Having Tony on staff is a major relief to me and allows me to focus on the big picture.

Job Corp continues to be the heart of the ministry. They are involved in all aspects of the ministry of the center. The work continues to spin the Lutheran Lakota Job Corp off as a separate 501c3. We are trying to raise \$150,000.00 this year to support the many fine JC workers.

The center and more importantly the staff of the center are making a difference. But it is only possible with the support we receive from the synod, the Episcopal Diocese, the ELCA, and the many people and churches that continue to support us.

South Dakota 2023-2024 Synod Council and Vice President Report

The Synod Council continues to meet and conduct the business of the Synod. We always keep in mind that we need to be good stewards of the Synod's assets and that our mission is to spread God's word and accompany individuals and Congregations in their faith journey.

Once again, the congregations of the South Dakota Synod and its individual members have been very faithful in their giving. But, because of a shortfall in the mission plan, an appeal was made to the congregations for a \$1 per confirmed member contribution above their normal giving. Thank you to all who participated. Because of your generosity, the mission plan was met, and the Synod was able to support all their important ministries. Just as with congregations, costs have continued to rise for the Synod and have required the Council to look closely at the mission plan. After much thoughtful deliberation, we hope that we have a plan that will continue the important work of the Synod.

One of the highlights of the year was the Lilly Grant that was awarded to the Synod to support Rural Ministries and develop learning systems. These funds are going to be invaluable in supporting the mission and goals of the Synod.

Several years ago, a seminary debt refinance program was put in place to refinance seminary debt for rostered leaders. A generous donor paid the interest on the loans so that all payments by rostered leaders went to principal. Through the faithful payments of the rostered leaders and through endowment distributions designated for seminary debt relief, all those loans have been repaid.

Highlights of Synod Council activities include:

- Continued support for the Pine Ridge Reconciliation Center and the great work done by Rev. Dan Johnson.
- Contacted congregations to express appreciation for ongoing mission support and listen to input on Synod activities.
- Approved distribution of endowment funds
- Heard reports from staff and mission partners
- Continued to partner with the McLaughlin Community Alliance Group.
- Continue to walk with new start congregations.
- Authorized disbursement of funds for Rostered leader and lay education.

Thank you to the Synod Council members who ended their term in 2024: Rev. Michael DeKraai, Dave Poppens, Rhonda Hansen, Rev. Dave Lund, Jeff Clark, Malcom Chapman, and Malorie Schultz. Also, thank you to Rev. Alyssa Mitchell, who left the council as she changed conferences. Thank you for participating on Synod Council and being flexible to meet on Zoom. Thank you to the Executive Committee for your willingness to meet monthly and provide leadership: Bishop Hagmaier, Rev. Jonathan Vehar, Terry Johnson, Malcom Chapman, Bonny Hansen, Rev. Jackie Braun and Dave Popppens.

A special thank you to Rev. Jonathan Vehar, who have been the Synod Secretary for almost seven years. His input to the Synod Council has been invaluable. I am very happy that he can continue to advise the council from his new position as Director of Evangelical Mission.

Welcome to Jill Beers, who agreed to step into the position as Synod Secretary.

The Synod staff continues their good work. Thank you to Bishop Constanze Hagmaier, Pastor Renee Splichal Larson, Pastor Jonathan Vehar, Lois Borchardt, Crystal McCormick, Rev. Alan Blankenfeld, Kathy McHenry and Rev Dr. Aaron Matson. The Synod is blessed to have these dedicated, talented individuals working to further the mission of the Synod. Thank you.

Also, thank you to the individuals who have agreed to serve on Synod Council for the coming year. The Council's work is important in providing leadership to the Synod. Bless you. I look forward to working with you during the coming year.

Sisters and Brothers in Christ:

The mission of the Synod's Candidacy Committee is to welcome, nurture, and guide deacon and pastor candidates in their discernment to answer God's call and to grow in service to our church.

There is great joy in sharing the rigorous path these candidates traverse.

This year, the SD Synod is walking with 16 candidates who are seeking to discern their roles serving the church as pastors and deacons. Another 20 potential candidates are in discussions discerning God's call.

We held another candidacy retreat in Sioux Falls, April 12 and 13, 2024. Twelve candidates and ten Candidacy Committee members were in attendance. The core theme of the retreat was on the candidate competency theme of "wellness" We concluded the retreat by worshipping with Pastor Chris Matson at The Church on the Street's Saturday worship and meal.

Building on the legacy of the 'Listen, God is Calling' campaign, all of our candidates for ordained ministry in the SD Synod have been supported by SD Synod seminary scholarships, graduating from seminary with no seminary debt. If there are people considering public, ordained ministry, but are worried about how to afford a seminary degree, assure them that there is financial aid from seminaries, the Fund for Leaders in Mission, and the SD Synod to assist them.

I close with this invitation to be part our work.

Virtually every congregation in the South Dakota Synod of ELCA has the opportunity to lift up people to explore their response to God's call. As you feel God's call to nurture faithful believers to consider this service to our synod, I encourage you to enable potential candidates to contact Reverend Renee' Splichal Larson at the SD Synod Office.

Report from Support to Ministries Prepared by Nancy Moose, Chair of Support to Ministries

Our Synod's Support to Ministries Committee is involved in supporting churches and pastors across our state. Because every conference is represented on this committee and because we can learn from each other, we hear about small churches, rural churches, large churches, and more urban churches. All have their own challenges and their own joys.

We primarily work with churches in transition and at each meeting we are updated about those who are in the process. The congregations are supported from the moment they learn that they will be tasked with calling a new pastor, to examining themselves and determining what type of person will best meet their needs, to providing names, to ordaining/blessing their newly called minister, to following up with those new in our conferences. This past year we have had fewer congregations and pastors in transition, a wonderful sign of stability in our synod.

Our committee has been working on "Supplemental Resource Guide for Church Councils, Call Committees & Call Chair", a document to help congregations as they begin the call process, one of the more important tasks a church can undertake. We have also been working with the Compensation and Guidelines Task Force, chaired by Annelies Seffrood. This group has been working to clarify language in several areas and to answer questions regarding compensation for all who work in and for a church/parish/congregation. Some of the new items in the compensation guidelines are related to additional holidays and prior experience along with further clarity regarding the roles of Synod Authorized Ministers (SAMs) and lay leaders. Reviewing the Compensation and Guidelines and recommending them to the Assembly is another important task of the Support to Ministries Committee.

This past year, the committee has worked to better support SAMs and the vital part they play in serving congregations in our Synod. We are also working to do more to support pastors new to South Dakota and to the culture of our rural communities.

The work of this committee is broad and varied. One of our future possibilities includes looking at documents which church leadership can use as an annual conversation/affirmation to look at congregation goals, mission, and vision as they move their congregations forward in the journey of doing God's work.

As Pastor Justion Kosec, the former chair of this committee, stated last year in his report, "We're here for you: to understand your challenges, to celebrate your successes, to help you navigate your changes, and to thank God for the good work you do every single week in service of the gospel." That statement is still true.

The good news of Jesus calls us to ask where the Spirit is leading and growing partnerships within our synod and our Neighbors in Solidarity.

This year, the newness includes welcoming Shepherd's Table, a Synodically Authorized Worshipping Community in Sioux Falls. Shepherd's table is intentionally making space by reaching out to people who have been longing for a place to belong and connect, including the LGBTQIA2S+ community. Shepherd's Table is opening doors and feeding people with the goodness of God's grace and boundless love.

Also, we said farewell to Rev. Jonathan Steiner, the Director of Evangelical Mission, and welcomed Rev. Jonathan Vehar, the new Director of Evangelical Mission. With Rev. Vehar's leadership, varied new ways of sharing the story of what God is up to through Neighbors in Solidarity are coming soon.

In 2023, the SD Synod's Neighbors in Solidarity Account provided each Neighbor with \$2,500, and \$39,557.80 was given for other needs as requested.

South Dakota Synod, ELCA Seminary Debt Reduction Update and Seminary Debt Refinancing Final Report March 15, 2024

History and Process:

Following a survey demonstrating a dramatic increase in seminary debt carried by pastors, the 1998 South Dakota Synod Assembly passed Resolution 25, directing the Synod Council to appoint a task force to study how the synod could provide financial assistance to ease the burden for pastors with seminary indebtedness.

Following approval of the task force's report and action by the 1999 Synod Assembly, the Synod Council created a restricted fund and an endowment fund for the acceptance of gifts, with an annual distribution from the endowment fund designated to reduce pastors' seminary indebtedness in the form of loans to be forgiven upon their completion of a fiveyear commitment to serve in the South Dakota Synod (reduced to one year in 2020.)

In 2015, based on debt reduction applications demonstrating a total of nearly \$1.3 Million in seminary debt carried by 28 pastors at an interest rate exceeding 6.5%, a proposal was presented to the Synod Council by Jim Schade, Executive Director of Lutheran Planned Giving of SD and Bishop David Zellmer, to reduce the pay-off length of these loans by 50%. This proposal was approved under the following terms:

- A line of credit was obtained through First Premier Bank, secured by the Engen real estate referred to above, with authorization to access up to \$500,000 to pay off seminary loans of approved applicants.
- Monthly payments made by rostered leaders via ACH, with interest on the loans paid by the synod's annual seminary debt reduction distribution (later amended due to a generous gift of annual interest payments by an anonymous donor), allowing 100% of rostered leaders' payments to reduce principal indebtedness.
- Loans to be secured by a promissory note and assignment of life insurance proceeds.
- Subsidy of interest payments ends if the rostered leader leaves active service in the Synod before the loan is paid.

Final approval of the program was given by the Synod Council on October 21, 2016, and the line of credit agreement was signed on December 16, 2016. The first loan was refinanced in May 2017.

With recognition of a changing landscape regarding seminary debt and interest rates, as well as concern for the Synod's liability exposure with unsecured loans, the Synod Council approved the debt reduction committee's recommendation to pause the acceptance of new refinancing applications in 2020.

Progress:

Since 2001, 115 South Dakota pastors have received just over 400 seminary debt reduction grants averaging \$3,000 each, for a total of \$1,212,135.25. This program continues because of annual distributions from the Clarence Engen Memorial Endowment and the generosity of additional designated gifts.

From May 2017 through July 2019, a total of 17 loans were refinanced through the South Dakota Synod, with a cumulative initial balance of \$553,441.76, or an average beginning loan balance of \$32,555.40. Each pastor's monthly payments were determined through the LSS student loan counseling service, with 100% applied toward the principal balance and zero accrued interest because of an annual donation. Additional payments in the form of seminary debt reduction grants reduced the payment schedule on these loans, anywhere from 10-14 years in some instances.

Celebration:

We invite you to rejoice with us today in celebrating the final payments of the two remaining refinanced loans in December 2023 with seminary debt reduction grants, giving thanks for the faithful homes that raised children who grew to become examples of Christ in their generosity during life and at death.

This refinancing program solved a problem during a time without many resources or solutions. We are abundantly thankful for the benefits it provided to congregations and to their rostered leaders and families, whose lives and financial futures have been changed. We are also grateful that the financial liabilities of a line of credit and outstanding loans have been eliminated, providing the same peace of mind to the South Dakota Synod. With generous seminary scholarships and eligibility for Public Service Loan Forgiveness programs, there is no longer a need for this method of financial support. Endowed distributions and gifts can now be directed to supporting intern sites and eliminating seminary debt more efficiently.

The South Dakota Synod is served today by pastors and deacons who may not have been able to accept a call to our rural places and lower-paying positions without these gifts. Our reputation of supporting rostered leaders invites and encourages candidates from across the country to seek calls in our state. Thanks be to God.

ELCA Region 3 Archives Report to 2024 Synod Assemblies

Introduction

2024 marks the 36th year of the ELCA Region 3 Archives. Paul Daniels continues in the archivist position at 80% time, half-time for the 9 synods of ELCA Region 3 and half-time for Luther Seminary. This shared position works well with Luther providing office and storage space as well as access to a much-needed volunteer pool and IT support. Luther profits from hosting the largest of the 9 ELCA regional collections as the materials are available for use by the entire seminary community.

Use of the ELCA Region 3 Archives

The Archives website, <u>www.luthersem.edu/archives</u>, continues to work well as our "front door" for promoting archival services to congregations and individuals. Luther Seminary provides IT support for the site and its regular updates. Researchers use the site for information on the collections as well as articles like "Ask the Archivist", focusing on particular archival topics pertinent to their church settings. Reference uses for the year were:

+Assisted a total of <u>808 reference patrons in the past year</u> with a range of research interests. The majority (62%) are congregational committees working on records scanning projects, anniversary celebration planning, church history writing and general records care questions. Other significant user groups include synod leadership, church wide offices and individual researchers.

+<u>Worked on a regular basis with all 9 synod offices</u>, collecting valuable office records and assisting with retention plans for each office. In an effort to reduce travel costs I now make an average of 2 visits per year to each of the 9 synod offices. In most cases, email, phone calls, and Zoom meetings are sufficient. These virtual visits were coordinated with <u>17 Zoom congregational visits</u> throughout the 3 states of ELCA Region 3.

Collection Growth

+Collected <u>187 linear feet of additional synod office records</u> from the 9 offices. These include legal, financial, personnel and program files. Much of this material is stored off-site in space leased from Iron Mountain Co. +Gathered <u>165 congregational pieces</u> adding to a collection now totaling over 7,300 files. +Received <u>422 biographical pieces</u> on clergy and lay leaders – total is now nearly 9,400 files. +Assisted 14 closing congregations in Region 3 with records care (scanning) and critical records collection.

Outreach and Education

+Distributed 56 copies of "Memory Work: A Guide for Congregational Archives and History" to congregations and individuals. The guide is frequently accessed digitally via the Region 3 Archives website.
+Managed off-site secure storage program via Iron Mountain Co. for permanent care of sensitive files, including candidacy, camping staff, and synod financial records.

+Promoted and managed the <u>congregational records scanning program</u> through Mid-America Business Systems.

Professional Development

+Daniels remains an active member of the Society of American Archivists, the Midwest Archives Conference, the Twin Cities Archives Roundtable and the Lutheran Historical Conference. Daniels renewed and maintained his professional certification in the Academy of Certified Archivists.

A generous grant from the Forum for Theological Exploration provided the financial support necessary to create the program.

Who are Buntrock Scholars?

The Buntrock Scholars Program supports students who are active and engaged in ELCA (Evangelical Lutheran Church in America) congregations in the Midwest. The program is open to those who are involved in the church before and after graduation from Augustana University.

What is the Buntrock Scholars Program?

The Buntrock Scholars Program provides financial support for selected students attending Augustana. This competitive scholarship covers half of the net price of attendance at Augustana, up to \$12,000 per year. The award is renewable for three additional years, and it can be received alongside other academic and talent-based scholarships. The program benefits at least 30 first-year students each year.

Requirements

Eligible students must be engaged in a Midwest ELCA congregation and remain in good academic standing at Augustana. After a student has applied and been offered admission to Augustana University, they must complete a scholarship form that includes a personal statement about the student's involvement in the church before and after college graduation, which will then prompt their senior pastor or youth pastor to submit a letter of recommendation. For congregations with pastoral vacancies, the council president or other elected leader may submit the recommendation. Applications will be reviewed beginning Dec. 1 until all available scholarships have been awarded.

Annual Report 2023

Dear Sisters and Brothers in Christ,

Grace and peace to you from God, our Father, and from our Lord and Savior, Jesus Christ. Amen!

Greeting from your sisters and brothers in Christ at St Dysmas Lutheran Church!

There is an old saying that the only constant is change; and 2023 lived up to that statement. Working inside the walls, especially in 2023, has seen some significant changes to policies, visitation requirements, and schedules. What we see as stumbling blocks, God uses to his glory. Even amidst the many challenges, God has been at work in amazing ways in the lives of people inside and outside the walls.

Firstly, thank you for your support to insure that the ministry of St Dysmas stays vibrant and active. We do not exist without the support and engagement from you. St Dysmas is YOUR ministry to those experiencing incarceration; and we are grateful for your partnership.

Here are a few highlights for this year:

- On any given day, there are approximately 3750 people incarcerated in the South Dakota Department of Corrections system. In 2023, we worked with and saw attendance of approximately 574 individuals to worship, Bible studies, and one-on-one pastoral care visits. Worship and Bible study attendance has steadily increased over the year at each site.
- We had 31 baptisms of adult men including 3 affirmations of baptism.
- We were able to hold special worship on Easter and Christmas Eve inside the facilities.
- Our Reformation Festivals took place at both Sioux Falls and Springfield on Reformation Weekend in October. A special meal was served at Springfield, and inmates were allowed to share the meal with their family that could attend.
- The annual special meal was held in Sioux Falls in August sponsored by Peace Lutheran Church in Sioux Falls.
- Worship switched to Tuesday evenings from 5:00 to 8:00 at Springfield. We have seen great participation by visitors to Springfield since this change occurred.
- Worship in Sioux Falls changed to Wednesday afternoons from 1:30 to 3:30. While this is not ideal, we have still had visitors attend very regularly.
- We have seen increasing engagement and attendance with our reentry work on the inside. Mitch Wilson worked with 244 individuals preparing to be released from incarceration.
- Accompanied 156 individuals once they were released to help them transition back into life on the outside.
- Mitch also worked in the Minnehaha County jail with 541 individuals housed there.
- Worked with the Department of Corrections and St Francis House to accompany 36 treatment women into work release.
- Over 3700 Christmas Treat Sacks were distributed the week before Christmas. Every person in the South Dakota Prison System received a sack, also people in the Minnehaha County and Yankton County jails.
- The Sioux Falls congregation again took up the challenge to support a ministry outside of themselves. All inmate offering goes to this fund, and for 2023, they will give Church on the Street a check for \$2271.
- The Springfield congregation took up the same challenge. They will distribute their funds after the January Inside Council Meeting. They will have approximately \$750 to distribute.
- I was able to visit 46 congregations to tell the story of St Dysmas and worship together.

These are just a few of the ways God has been at work through St Dysmas. I give thanks to God for the many gifts that the has entrusted to us. Through the faithful partnership of many of you, we continue to be able to proclaim the good news of Jesus Christ to this who need to hear it most; "setting the captives free…"

The Good Samaritan Society (the Society) is one of the nation's largest non-profit providers of senior care and services, offering home-based services, skilled nursing and rehabilitation therapy, assisted living and independent senior housing. We are proudly affiliated with the Evangelical Lutheran Church in America (ELCA), and in 2022 we celebrated 100 years of mission-centered service to seniors and individuals with disabilities. We are honored to provide compassionate services and care to those in our communities who need us.

The Society came together with Sanford Health in 2019 to create an integrated health care system that provides care services across the lifespan. After more than five years as a combined organization, we are seeing how our partnership is helping communities thrive.

Presence in the South Dakota Synod

Though our services extend far beyond South Dakota, we are especially proud to call Sioux Falls the headquarters of both the Society and Sanford Health. We also offer skilled nursing, assisted living, senior housing and home-based services across the state—including in Canistota; Canton; Clear Lake; Corsica; De Smet; Herreid; Howard; Miller; New Underwood; Rapid City (Echo Ridge and St. Martin Village); Scotland; Sioux Falls (Sioux Falls Center, Prairie Creek and Sioux Falls Village); and Tyndall. In 2024, we announced plans to develop a first-of-its-kind senior living community in Sioux Falls called <u>Good Samaritan Society – Founder's Crossing</u>. The leading-edge campus will offer all health and wellness services under one roof, including a direct connection to a Sanford Health clinic and Lewis Drug.

We are honored to serve many members of the South Dakota Synod and partner with Rostered Ministers to meet the needs of our residents and clients.

Public Advocacy

More than 70 percent of the residents we serve live in rural communities, and we remain resolute in ensuring they have access to care as close to home as possible. The pandemic has put unprecedented stress on the senior care industry. We are working with state and federal policymakers to advocate for our seniors and the caregivers who serve them. We are committed to working with partners in the senior care industry to find permanent and meaningful solutions to support and address our workforce and resident care needs now and in the future.

ELCA Endowment for the Elderly

In 2023 the Society was awarded a \$25,000 grant through the ELCA Endowment for the Elderly. These funds allowed us to pilot a program at our skilled nursing facilities in New Hope, and Robbinsdale, MN, to host artistic performers who commemorated PRIDE Month, Juneteenth, Hispanic Heritage Month and Native American Heritage Month.

In 2024 we were awarded an additional \$75,000 from the same endowment for a three-year pilot Culinary Culture Project. With this new funding we will facilitate multicultural food events at three of our campuses, including two in the South Dakota Synod: Sioux Falls Village and St. Martin Village (Rapid City).

SD Synodical Women of the ELCA Report to the Synod Assembly

Our 36th Annual Synodical Convention was held at Calvary Lutheran Church in Rapid City, which is in our Bear Butte Conference. There were 76 women in attendance. The theme was "All Are Welcome" and our theme verse was I Corinthians 16:14, "Let all that you do, be done in Love." We had evening vespers at the Chapel in the Hills on Wednesday evening. Thursday's main speaker was Kelly Patterson, on sex trafficking; she is the author of a book on her true story "From Trafficked to Treasured". The day was filled with many interesting speakers, and our CW speaker from AZ, was Laura Krueger. After our Business meeting, we closed Friday am with a Holy Communion Service.

On August 12th, 2023 our first Biennual Leadership Event for Conference Officers was held at Trinity Lutheran Church in Chamberlain. All Conference officers were encouraged to attend to learn, ask questions, and engage in conversations with others, for the purpose of strengthening their leadership skills.

On September 21-24, 19 women from South Dakota went to Phoenix AZ, for the Twelfth Triennial Convention. The 4 voting delegates were Sherry Archer, Kathy Heffernan, Lois Storm, and Darla Tobin. Our Main Theme was "Just Love" through the lens of immigration, migration, and human trafficking Two of our Key Speakers were Dr. Jacqueline Bussie, who is the author of a book: "Love Without Limits" and Dr. Kelly Sherman-Conroy, a Native American, who shared stories of the atrocities that her ancestors went through. Also, as speakers, were several students from various foreign countries who addressed racism, homesickness, and learning a new language and etc. We had choices on different workshops to choose from and they were very interesting. It was wonderful to be there.

Each of the 7 Conferences in the state have a Fall Workshop and Spring Gathering. At the meetings women can fellowship together, be entertained, conduct their Conference business, and open and close with worship together.

A Zoom meeting on Saturday, April 6th was held from 12:00-5:30, with the other Churchwide Synodical Presidents. Our meeting was titled Re-remembering, Rebuilding Leadership and was very interesting for us.

The SD Synodical Officers have been busy planning and preparing for this year's 37th Convention at First Lutheran Church in the Prairie Rivers Conference, which will be held on June 19-21. All women of the ELCA are encouraged to attend.

Women of the SD Synod continue to serve with the making of many quilts which are boxed up for LWR, and also given out to local communities that are in need of them across SD. We also put together personal care kits, school kits, pillow cases, fabric kits, and newborn kits which are shipped to LWR. We do hospice kits, rolled bandages, newborn kits, quilts for missions, baby blankets, and baby hats which are made for Global Health Ministries. We also make mats for the homeless, give gifts to local food pantries, and support projects of LO and LSS. We thank the women of our synod for serving as officers in their church, conference, and on the synodical board, and for being wonderful leaders. We thank the women of our synod for the many ways that they serve in their churches and communities and are really the hands, feet, and heart of all our 7 conferences across SD. We pray that together we can bring hope and joy as we work together into the future.

The University Lutheran Center is a place of transformation! Transformation happens in a myriad of ways from the ministry programs we lead to making a difference in the lives of others, and from the building that has been changed to better suit our needs to the students who are personally impacted by the ways God shows up in their lives. Seven semesters ago, I arrived here. In the midst of the pandemic and a pastoral vacancy, much had been neglected and pruned away. Since then this place has been transformed! And while the people here have rolled up their sleeves and done some of that work, we also know deeply that God has showed up to make much of the transformation we have experienced happen.

On that very first Sunday, we gathered ten people. That core of students were the root of our transformation journey these last three and a half years. They showed up when we thought no one would. They took a risk to invest in a small campus ministry and most of them stuck around. We are now connected with more than sixty students, and our average attendance at most gatherings is over double that original ten students. At the close of this academic year, most of that original core will have graduated. In fact, we have eleven graduates this year! That is the nature of the work of campus ministry. We always find ourselves welcoming people and blessing them on the journey ahead. And in the process, we are transformed by the relationships we have with one another in this community.

Transformation happens in big and small ways here. Our programming gathers students for worship and free lunch on Sunday mornings and on Wednesday evenings for Bible study and snacks. On Thursday evenings, our building is open for studying, socializing, caffeinating, and brain breaks. We take the transforming message of God's boundless love across the street to campus on a routine basis offering a variety of swag along with relevant messaging. We also find plenty of time for fun during our time together. This year that included several game nights, a retreat at Shetek Lutheran Ministries, ice skating, a Stampede hockey game, and an end-of-year bowling celebration. During finals, we keep the lights on, the caffeine flowing, and bellies full at almost all hours of the day and night, hoping to cheer students on to successful completion of their courses. Additionally, we saw God transform the lives of two of our students through the Sacrament of Baptism this year.

Our community also has the opportunity to transform the lives of others through service opportunities. This year, we volunteered with the Brookings Backpack Project and Sleep in Heavenly Peace. We also loaded the WELCA semi with items for Lutheran World Relief and made fleece tie blankets for foster children that are distributed through the local Department of Social Services. A group of ten from our community were also transformed through a service learning trip to Seattle over spring break. We served at a food pantry, cooked at a day shelter, cleaned a community room at a subsidized apartment complex, scrubbed a kitchen that feeds teens experiencing houselessness, learned about advocacy, experienced new worshiping communities, and contemplated how all of this impacts us as fellow sojourners in this world.

Students spend many hours in our building each week, to the point that we found ourselves needing more space so they can spread out and faster internet to keep up with their demand. Last summer we renovated an extra office into a study room which has been much appreciated by our students. This semester, thanks to a generous donation, we have completely renovated the basement into a lounge space with a television, sectional, and a ping pong table. The basement also has two bathrooms with showers and a laundry facility with two washers and two dryers. Next fall, we will launch a laundry program for students. This building transformation will likely bring even more students to our space for even more hours of the week. And it goes so much further than clean laundry. In this place seeds get planted along the way, helping college students recognize that the church cares about them, their laundry, their homework, their caffeine needs, and their belovedness as children of God.

I know that the community that was created this year at the ULC will continue to be transformed. Some of them will take this experience with them into new adventures. However, a majority of our community will return to this place and continue the ministry of invitation next fall, so that other Jackrabbits may find welcome, community, and transformation in this place.

We cannot be a vessel of this transformative work without our partners in ministry! A huge thank you to the synod, congregations, WELCA organizations, and individuals whose generosity does not go unnoticed. We hope you will continue to support us in our transformative work. Beyond financial support, we also want to connect with young adults from your communities as they make their way to SDSU to further their education. The Chapel in the Hills is a 501(c)(3) nonprofit corporation formed to maintain and operate the Chapel in the Hills, in Rapid City. We are considered a Special Partnership Ministry of the South Dakota Synod, ELCA. The Chapel and grounds are open to visitors from May 1st to September 30th and during special services and events the remainder of the year.

The Chapel offers a quiet, retreat-like setting in the midst of the hustle and bustle of vacation and offers a place for tourists and local residents alike to slow down, relax, and enjoy Christ's presence. The Chapel fills a unique niche in the Synod's evangelism efforts, sharing our Lutheran heritage and traditions. Visitation remains high, with approximately 30,000 visitors annually, coming from every U.S. state and numerous countries.

Evening worship services are held Wednesdays, Saturdays, and Sundays at 7:30 PM throughout the summer, continuing the tradition that began when the Chapel was the home of the *Lutheran Vespers* radio program. The Chapel continues to host other special services and events throughout the year, along with numerous weddings and renewal of vows ceremonies. In addition, we continue to seek ways to extend our mission to the local community and beyond. We continue to host ELCA clergy from all over the country to serve as our guest pastors. This program has been very popular with all involved, as our guest pastors share their ministry with our visitors and carry back awareness of the Chapel and our ministry to their own congregations and friends. SD Synod Coaching Coordinator Team Report – March 2024

The SD synod coaching team is led by Jamie Duprey, SD coaching coordinator and ELCA Coaching mentor coordinator. Members of the team include Jackie Braun, Wilbur Holz, John Paulson, Jeremy Duprey, Laura Campell, Jess Daum, Renae Boemer, and Cassandra Lamb. We meet quarterly, at minimum, to discuss ideas and opportunities to create and cultivate partnerships and pathways for coaching in our synod.

Current State of SD Coaching

- The SD Synod coaching cohort has seven (7) segment 1 trained coaches.
- We have coaches trained in ELCA Coaching segment 2 specialty coaching including Discipleship, Stewardship, Mission Development/Redevelopment, and Care for Creation certification.
- We have one coach who is International Coaching Federation (ICF) certified at the professional level of certification (PCC) with an emphasis on grief coaching and one coach who has gone through the associate certification grief coaching course as well.

Coaching Support and Training

- The SD Synod coaching team is in consistent correspondence with Jill Beverlin, Jason O'Neill, David Hively, and other coaching coordinators across ELCA churchwide.
- Active Status is defined as:
 - Connecting 3-6 times a year with synodical coaches for support and training
 - Coaching at least two (2) clients for ten or more hours (total) annually
 - Following the ICF Core Competencies and Ethical Guidelines
 - Submit annually a recorded coaching session for review
 - Four (4) hours minimum per year of continuing education/coach specific training; ELCA Coaching is partnering with Dr. Don Eisenhauer at Coaching at End of Life to provide free continuing ed opportunities
- ELCA segment 1 training enables participants to be certified as segment 1 ELCA coaches. On April 5-6, 2024, a live training will take place at First Lutheran Church in Brookings where six people will engage in the segment 1 training for the first time; two participants will engage as returning learners.

Coaching in the SD Synod

 Bishop Hagmaier and associates Renee Splichal Larson and Jonathan Vehar have all been through ELCA segment 1 training. We value the partnership we have with the bishop and her staff. We look forward to continuing our work together to support and empower servant-leaders for Christ in and through the SD Synod—and beyond—as we help those who coach and are coached maximize their God-given gifts and potential.

- The synod staff has been most supportive in helping create venues where coaching can be utilized and help advance the mission of the synod.
- Current venues where coaching is offered include: first-call, ELCA World Hunger, ELCA Growing Younger, Coaching Around Stress and Crises.
- Pastor Jonathan Vehar is in continued conversation with Jamie Duprey regarding ways to continue to support leaders through coaching, and to continue broadening partnerships and pathways for coaching in our synod.
- The challenge remains to continue promoting and advocating for coaching. Coaching is often perceived to be for those who "need help" or are somehow not performing up to expectations. Clients who undergo the most transformation are, in fact, high performing individuals who want to fully develop their potential and grow more fully into the person God has created them to be.
- We look forward to finding new and creative ways to help rostered and lay leaders discover the power of coaching and how it can help them live more fully into God's dream for their lives and congregations.

In partnership with Young Adult Ministries, we've trained 33 young adults in coaching skills, and they are supporting other young adults as they work in ministries across the ELCA

Spanish Language Coach Training

In partnership with native speakers, we have developed coach training materials in Spanish. Class participants are on the front lines of ministry in Latine communities.

Land Back Conversations

We partner with Indigenous leaders to help congregations begin a conversation about the Land Back and Truth and Healing Movements.

COACHING IN EVERYDAY LIFE

In 2024 we are offering a new course to equip individuals with the primary skills used by executive and life coaches: intense listening and high-powered question creation. Combining these two skills produces conversations that result in much richer output and more profound understanding between the participants. Once familiar with these coaching skills, they can be applied to any conversation, whether a response to a short text blast, a dinner table conversation, or an office chat. Your conversations with friends, family, co-workers, and team members will take on the characteristic of being supportive, nonaggressive, and non-judgmental, which ultimately builds solid and trusted relationships. 

Fiscal 2022–23 was a year of transition and transformation at Luther Seminary.

Transition: Across our educational programs, we are working to create sustainable new models so that learners can afford not just theological education, but life in Christian leadership.

Transformation: We continue to witness how the Jubilee Scholarship creates a path for students from all walks of life to answer God's call to ministry. Since implementing this full-tuition scholarship model in 2018, student borrowing has dropped to its lowest level at the seminary in nearly 25 years. A remarkable 67% of our 2023 class graduated with zero student debt.

At the same time, we continue to expand the accessibility of theological education beyond our degree programs through Faith+Lead and digital media like Working Preacher, Enter the Bible, and God Pause. Combined visits to our digital properties and podcast downloads topped 5 million unique visitors in 2022–23, a 20% increase over the previous year.

Transition: With the close of the MDivX pilot program this spring, we are pivoting toward a permanent option for an accelerated M.Div. pathway.

Transformation: MDivX was a resounding success, demonstrating the effectiveness and appeal of a two-year model with simultaneous contextual learning. Retention in the pilot program was extraordinarily high, with 96% of participants graduating. Out of the 51 graduates from the first two cohorts, 47 are actively serving in ministry contexts at the time of this writing, with one in the process of becoming ordained.

The lessons from MDivX helped shape a larger curriculum refresh that reflects our students' and the church's needs. The

faculty applied insights from MDivX, deep listening to the church, and assessment data in redesigning the curriculum last year for a Fall 2023 implementation. This curricular "refresh" strengthens course sequencing to support learning outcomes, creates natural cohorts through three defined pathways (full-time, part-time, and, in the future, accelerated), and reduces requirements without sacrificing depth or rigor.

Transition: We are in the midst of two budget years designed to support investments in our strategic plan priorities and key financial goals, including increasing Faith+Lead revenue and restructuring the academic programs for efficiency. Modest operating deficits planned for these two years are supported by the seminary's strong cash position and robust \$120 million endowment valuation as of June 30, 2023.

Transformation: I'm grateful to share with you this snapshot of the "good works" for which God has equipped Luther Seminary. And yet, we know that the true outcomes of the Holy Spirit's action with and through us ripple out far beyond what can be quantified in any financial report.

Thank you for your prayerful support as we seek to faithfully steward the gifts and mission of this community for the future of Christ's church.

AT A GLANCE

- The seminary awarded 439 scholarships in 2022–23.
- Master of Arts students like Ryan made up 62% of enrolled students.
- As scholarship recipients, Ryan and Laura received part of the \$6.15 million awarded during the 2022–23 academic year. On average, students received \$11,033 in scholarships and grants from Luther Seminary.
- Laura was among the 28% of students who pursued a Master of Divinity degree in 2022–23.
- Financial aid covered 100% of the cost of tuition for qualified incoming M.A. and M.Div. students.

BY THE NUMBERS

- 412 students enrolled at Luther Seminary during the 2022–23 academic year.
- ELCA members accounted for 71% of the student body. 34 denominations made up the remaining 29% of students.
- Tuition, student fees, books, and on-campus living expenses cost approximately \$43,911 for full-time students.

DURING THE 2022–23 FISCAL YEAR

36 international students enrolled from 23 countries.

138 students graduated May 21. Donor sources made up 96% of Luther Seminary's operating revenue when combining individual donor support, the endowment, and church and synod appropriations.

MEET RYAN

Having been influenced by philosopher Charles Taylor, **Ryan Popineau '24 M.A.** came to Luther Seminary in order to study with Professor **Andrew Root**, who has written about the implications of Taylor's ideas on ministry. A hospice chaplain and former youth pastor, Ryan is able to apply what he is learning to his work. After graduation, he hopes to write and speak on practical steps pastors and churches can take to minister in the world. "I wanted to attend seminary for nearly 15 2024 Symetryseid. "The Jubilee Scholarship made attendance an opportunity I could not pass up." Preliminary Report Laura Otieno '27 M.Div. enrolled in seminary to deepen her understanding of her faith and become a more confident leader, seeking ways to engage individuals and communities with the gospel. Having pursued an undergraduate degree in social work and a master's in nonprofit management while working, she maintains a full-time job in higher education while she studies at Luther Seminary. "The Jubilee Scholarship made seminary accessible to me," she said. "The financial barrier would have kept me from future studying, but now I have the opportunity to develop as a leader." ⁵⁶





Dear Partners in the South Dakota Synod,

Greetings from your siblings in Christ at Wartburg Theological Seminary, in Dubuque, Iowa. I am pleased to have the opportunity to share with you some of the ways the Holy Spirit is at work in and through your seminary.

First, we are delighted to announce the successful completion of Lead Boldly!, our comprehensive capital campaign. We exceeded our goal of \$28 million, which included enthusiastic support for student scholarships, one of our highest priorities. As a part of this ambitious campaign, we also are very pleased to announce the completion of an extensive remodel of our primary educational and office building, Fritschel Hall. This project came in under budget and on time, thanks to the excellent work of our staff and our local construction partners. We would love to show you the renovated educational space; please know that you are invited to visit anytime!

Second, I want to share with you a new emphasis that Wartburg is placing on TEEM and Certificate Programs, exemplified by the new director of these programs, Pastor Carrie Greenquist-Petersen. I invited Pastor Carrie to share some thoughts with you about this program:

Over the past nine months it has been my privilege and pleasure to help Wartburg welcome and serve TEEM candidates for rostered ministry, lay leaders, synods and partners. I have gotten to know the students through admissions, candidacy processes, contextual education, classes/modules and endeavored to nurture an identity of quality and worth in Wartburg's TEEM and Certificate students. Clear and timely communication can make the difference between feeling forgotten and feeling immensely valued. This is why being available to all partners to hear and address any question or concern is my top priority. It is a true joy to accompany each student along their path of discernment for leadership in Christ's church.

Third, Wartburg Seminary is announcing the launch of a Congregational Accompaniment Project to equip congregations for intercultural competence and to open doors to new mission opportunities with Latine people. This project aims to foster deeper understanding of diversity and to cultivate the development of meaningful relationships that reflect the love of Christ. Upon application, Wartburg staff from the Centro Teológico Luterano Multicultural and the Journey Together program will accompany congregations and their leaders in this process.

Finally, we have a new tagline at Wartburg, which speaks directly to our sense of mission in the current moment in the life of the church: *Listen. Wonder. Lead.* "At Wartburg Theological Seminary the voices of God and our neighbors call us to *listen* deeply. In these limestone halls and your local communities, Jesus' love invites us to *wonder* that transformative power of the Holy Spirit, who inspires our life together. Our graduates *lead* a changing church with holy curiosity, creativity and joy. In hope, we proclaim God's grace that carries us through death to resurrection life. Listen, wonder, and lead at Wartburg."



MESSAGE FROM OUR EXECUTIVE DIRECTOR: Into the Faithful Future

ear friends of Seafarers International House (SIH):

"Though your beginning was small, your latter days will be very great. " Job 8:7

In 2023, Seafarers International House celebrated its 150th anniversary of uninterrupted service to well over two million people. Starting humbly with one pastor in 1873, we have been fulfilling our mission of being the *Lutheran response to the urgent needs of vulnerable seafarers and immigrants*, or more succinct: of welcoming in the stranger.

Reflecting on our past, of the evolution of our services, always adapting, often moving physically from one guesthouse building to the next, we have reaffirmed that Seafarers International House is not a place but a service. In 2023, we welcomed fifty asylum seekers and provided them with free lodging and assistance from our new Social Worker, Michael Bradford, who collaborates with me tirelessly to make people who escaped violence and persecution feel at home, enabling many to become contributing members of their new homeland. We also offered 159 seafarers, often young mariners starting their careers or senior seafarers transitioning into retirement, affordable accommodations as they prepared for their next 3-6 months voyage or starting a new chapter of life, respectively.

During 2023, we strengthened our partnership with the Albany Maritime Ministry (AMM) with Pastors Kate Drefke and Lowell Chilton and hired Rev. Jonathan Westerlund to aid in the busy port of New Jersey & New York. In all ports, including Baltimore and New Haven, we visited 1,094 ships with 2024 Synod Assembly 12,522 crew members, bringing onboard essentials and being present and transporting 2,061 of these seafarers to the mall or medical facilities.

Thanks to many individuals, youth and business groups, and congregations, a record 3,216 seafarers regardless of their faith felt some Holiday cheer when they opened their Christmas-at-Sea satchels filled with warm clothing and season's greetings, letting them know that we appreciate their sacrifices while they transport 90% of the things we use. Just look at the faces on the cover of this report and you can see the joy you have spread!

With our partners in the shipping industry, ship owners, and unions we celebrated our 150th anniversary at the Setting the Course Reception breaking an income record of over \$250,000 in crucial support of our Port Mission and subsidized lodging for mariners. We are grateful for the 2023 honorees John Atkins (Global Container Terminals), Mark W. Barker (Interlake Maritime Services), and Adam Vokac (Marine Engineers' Beneficial Association.

Yet, we also used the anniversary year to address future concerns. Through strategic planning involving all board members as well as members of the communities we serve, we determined that the current arrangement of renting our guesthouse to Breaking Ground furthers our mission by providing vital income to help us expand the port mission while continuing excellent lodging to asylum seekers and seafarers at the Markle Residence of the Salvation Army. This formula will allow us to save funds, complemented with donations from a comprehensive campaign, to eventually purchase




3,216 seafarers, regardless of faith, received Christmas-at-Sea satchels filled with warm clothing and holiday greetings prepared by volunteers to recognize these essential workers. This exceeds last year's record of 2,915! **50** asylum seekers received free lodging for a total of 766 nights. They hailed from Afghanistan, Angola, Benin, Chad, Dominican Republic, Ecuador, El Salvador, Ethiopia, Ghana, Guatemala, Haiti, Honduras, Iran, Jamaica, Liberia, Libya, Nicaragua, Pakistan, Peru, Sudan, Tunisia, Ukraine, and Venezuela. 2023 FINANCIAL REPORT

In accordance with our 2024 - 2028 strategic plan, operating gains help to build reserves for a new property (\$1M) with mission-based guest rooms and offices and to allow for capital repairs on the guesthouse (\$400,000), which is leased to Breaking Ground, which offers transitional housing to the community. That lease revenue supports our mission to seafarers and immigrants. Donations remain a vital pillar of income to support our services and future expansion.

Program services and reserves accounted for 88% percent of expenses with only 12% spent on support services and fundraising. Net Assets increased from \$8,258,768 in 2022 to about \$10 million. These figures reflect *unaudited revenue and expenses and are subject to change*. To request the audited 2023 financial statements send an email to henryk@sihnyc.org.

CONSTITUTION, BYLAWS AND CONTINUING RESOLUTIONS

- d. providing ecumenical guidance and encouragement.
- **†S6.04.** Except as otherwise provided in this constitution and bylaws, the Synod Council shall establish processes that will ensure that at least 60 percent of the members of the synod assemblies, councils, committees, boards, and other organizational units shall be laypersons; and that, as nearly as possible, at least 45 percent of the lay members of assemblies, councils, committees, boards, or other organizational units shall be women and, as nearly as possible, at least 45 percent shall be men; and that, where possible, the representation of rostered ministers shall include both men and women. This synod shall establish processes that will enable it to reach a minimum goal that 10 percent of its assemblies, councils, committees, boards, or other organizational units be persons of color and/or persons whose primary language is other than English.
- <u>†S6.04.01.</u> It is the goal of this synod that at least 10 percent of the voting members of the Synod Assembly, Synod Council, committees, and organizational units of this synod be youth and young adults. The Synod Council shall establish a plan for implementing this goal. For purposes of the constitution, bylaws, and continuing resolutions of this synod, the term "youth" means a voting member of a congregation who has not reached the age of 18 at the time of election or appointment for service. The term "young adult" means a voting member of a congregation between the ages of 18 and 30 at the time of election or appointment for service.
- <u>S6.04.03.</u> The Synod Council shall allocate numbers and categories of Churchwide Assembly members and alternates among the conferences of this synod. Each conference shall nominate members and alternates of the Churchwide Assembly according to the Synod Council allocation and according to that conference's nomination procedures. Members and alternates elected shall be ratified by the Bishop.
- **†S6.05.** Each assembly, council, committee, board, commission, task force, or other body of this synod or any synod units shall be conclusively presumed to have been properly constituted, and neither the method of selection nor the composition of any such assembly, council, committee, board, commission, task force, or other body may be challenged in a court of law by any person or be used as the basis of a challenge in a court of law to the validity or effect of any action taken or authorized by any such assembly, council, committee, board, commission, task force, or other body.
- **†S6.06.** References herein to the nature of the relationship between the three expressions of this church congregations, synods, and the churchwide organization as being interdependent or as being in a partnership relationship describe the mutual responsibility of these expressions in God's mission and the fulfillment of the purposes of this church as described in this chapter, and do not imply or describe the creation of partnerships, co-ventures, agencies, or other legal relationships recognized in civil law.

Chapter 7. SYNOD ASSEMBLY

- **†S**7.01. This synod shall have a Synod Assembly, which shall be its highest legislative authority. The powers of the Synod Assembly are limited only by the provisions in the Articles of Incorporation, this constitution and bylaws, the assembly's own resolutions, and the constitutions and bylaws of the Evangelical Lutheran Church in America. †S7.11. A regular meeting of the Synod Assembly shall be held at least triennially. S7.11.01. The time and place of the South Dakota Synod Assembly shall be determined by the Synod Council. The time and place the next regular assembly normally shall be announced 12 months prior to the assembly. S7.12. Special meetings of the Synod Assembly may be called by the bishop with the consent of the Synod Council, and shall be called by the bishop at the request of one-fifth of the voting members of the Synod Assembly. The notice of each special meeting shall define the purpose for which it is to be held. The scope a. of actions to be taken at such a special meeting shall be limited to the subject matter(s) described in the notice. b. If the special meeting of the Synod Assembly is required for the purpose of electing a successor bishop because of death, resignation, or inability to serve, the special meeting shall be called by the Synod Council after consultation with the presiding bishop of the Evangelical Lutheran Church in America. S7.13.
- **S7.13.** Notice of the time and place of all meetings of the Synod Assembly shall be given by the secretary of this synod.

- S7.13.01. Notice of the date, time and place of the meeting of the Synod Assembly shall be published in official publications established by this Synod or mailed to the rostered ministers of the Evangelical Lutheran Church in America, and of this synod and congregations, not less than 90 days before the meeting of the Assembly.
- **S7.14.** One-half of members of the Synod Assembly shall constitute a quorum.
- **†S7.21.** The membership of the Synod Assembly, of which at least 60 percent of the voting membership shall be composed of lay persons, shall be constituted as follows:
 - a. All rostered ministers under call on the roster of this synod shall be voting members of the Synod Assembly.
 - b. A minimum of one lay member elected by each congregation with fewer than 175 baptized members and a minimum of two lay members elected by each congregation with 175 ormore baptized members related to this synod, typically one of whom shall be a man and one of whom shall be a woman, shall be voting members. The Synod Council shall establish a formula to provide additional lay representation from congregations on the basis of the number of baptized members in the congregation. The Synod Council shall seek to ensure that, as nearly as possible, at least 45 percent of the lay members of the assembly shall be women and, as nearly as possible, at least 45 percent shall be men.

- Voting membership shall include the officers of this synod. Any congregation of this synod which elects a 16-21 year old as a voting member shall be
 - granted one additional voting member. Any congregation of this synod which elects a person of color and/or a person whose primary language is other than English as a voting member shall also be granted one additional voting member. The number of lay voting members per congregation is determined by the following scale:

S7.21.B17Rostered ministers of Word and Sacrament from a church body with which a relationship of
full communion has been declared and established by a Churchwide Assembly of the
Evangelical Lutheran Church in America shall be granted the privilege of both voice and vote
in the Synod Assembly during the period of called or contracted service in a congregation of
this synod, in accord with ELCA churchwide bylaw 8.72.12.

- S7.21.C17Rostered ministers of Word and Sacrament serving as interim pastors, under contract to a
congregation of this synod, shall be granted the privilege of both voice and vote in the Synod
Assembly during the period of contracted service in a congregation of this synod.
- S7.21.D17 Synodically Authorized Ministers (SAMs) certified by the South Dakota Synod, under contract to a congregation of this synod, shall be granted the privilege of both voice and vote, as an additional lay member, in the Synod Assembly during the period of contracted service in a congregation of this synod.
- S7.21.E22Each Synod Authorized Worshiping Community under the purview of the South Dakota Synod shall
be afforded voting members, in addition to the Synod Authorized Minister, in accordance with
S7.21. and S7.21.A07

- **S7.21.01.** Voting members shall begin serving with the opening of a regular Synod Assembly and shall continue serving until voting members are seated at the next regular Synod Assembly.
- **†S7.21.02.** If a special Synod Assembly is called and voting members at the previous assembly are unable to serve as voting members, where permitted by state law, the congregation through the Congregation Council may elect new members who shall continue to serve until the next regular Synod Assembly.
- **S7.22.** This synod may establish processes that permit retired rostered ministers, or those granted disability status, or on leave from call, on the roster of the synod to serve as voting members of the Synod Assembly, consistent with †7.21.c. If the synod does not establish processes to permit the rostered ministers specified above to serve as voting members, they shall have voice but not vote in the meetings of the Synod Assembly.
- **†S7.23.** The presiding bishop of the Evangelical Lutheran Church in America and such other official representatives of the churchwide organization as may be designated by the presiding bishop, shall have voice but not vote in the meetings of the Synod Assembly. Like privileges shall be accorded to those additional persons whom the Synod Assembly or the Synod Council shall from time to time designate.
- **S7.24.** Ministers under call on the rosters of this synod shall remain as members of the Synod Assembly so long as they remain under call and so long as their names appear on the rosters of this synod. Lay members of the Synod Assembly representing congregations shall continue as such until replaced by the election of new members or until they have been disqualified by termination of membership. Normally, congregations will hold elections prior to each regular meeting of the Synod Assembly.
- **†S7.25.** Except as otherwise provided in this constitution or in the *Constitution, Bylaws, and Continuing Resolutions of the Evangelical Lutheran Church in America*, each voting member of the Synod Assembly shall be a voting member of a congregation of this synod.
- **S7.26.** This synod may establish processes through the Synod Council that permit representatives of authorized worshiping communities of this synod, which have been authorized under ELCA bylaw 10.01.04., to serve as voting members of the Synod Assembly, consistent with †S7.21.
- **S7.27.** This synod may establish processes through the Synod Council to grant a minister of Word and Sacrament from a church body with which a relationship of full communion has been declared and established by the Churchwide Assembly of the Evangelical Lutheran Church in America the privilege of both voice and vote in the Synod Assembly during the period of that minister's service in a congregation of this church.
- **S7.28.** Duly elected voting members of the Synod Council who are not otherwise voting members of the Synod Assembly under †S7.21. shall be granted the privilege of both voice and vote as members of the Synod Assembly.
- **†S7.31.** Proxy and absentee voting shall not be permitted in the transaction of any business of the Synod Assembly.
- **S7.32.** Robert's Rules of Order, latest edition, shall govern parliamentary procedure of the Synod Assembly, unless otherwise ordered by the assembly.
- **S7.33.** *"Ex-officio"* as used herein means membership with full rights of voice and vote unless otherwise expressly limited.

S7.40. Committees of the Synod Assembly

S7.40.10. Credentials Committee

<u>S7.40.11.</u> Prior to the Synod Assembly, the Synod Bishop shall appoint three persons to act as a Credentials Committee. This committee shall report when requested on the number of voting members, visitors, advisors, and others in attendance.

S7.40.20. Election Committee

S7.40.21.Prior to the Synod Assembly, the Synod Bishop shall appoint three ministers of Word and Sacrament
and three laypersons to an Election Committee to supervise elections and announce the results to the
Synod Assembly.

S7.40.30. Resolutions Committee

- <u>S7.40.31.</u> Each conference shall elect one representative to a Resolutions Committee. The Synod Bishop shall appoint two representatives at large, and shall designate the convener of the committee. In the case of a vacancy, the Synod Bishop will appoint a replacement.
- <u>S7.40.32.</u> The committee shall elect its own leadership.
- S7.40.33.The committee shall receive all resolutions, prepare them, and make recommendations on them in
accordance with the Synod Rules of Parliamentary Procedure for transmission to the Synod Assembly.
S7.40.34.S7.40.34.The committee shall draft such resolutions as it is instructed to draft by the Synod Assembly, and may

draft others it deems necessary.

S7.50. Conference Caucus

- <u>S7.50.10.</u> The members of the Synod Assembly from each conference shall constitute the conference caucus.
- <u>S7.50.11.</u> The caucus may draft resolutions for submission to the Resolutions Committee.
- <u>S7.50.12.</u> The caucus may discuss resolutions, and transact such other business as the voting members determine.
- <u>S7.50.13.</u> The caucus shall meet at the call of the Bishop, the President of the Conference or the request of 15 percent of the voting members of the conference.
- <u>S7.50.14.</u> The officers of the conference shall serve as the leadership of the caucus.

Chapter 8. OFFICERS

†S8.01. The officers of this synod shall be a bishop, a vice president, a secretary, and a treasurer.

S8.10. Bishop


- **†S8.11.** The bishop shall be elected by the Synod Assembly. The bishop shall be a minister of Word and Sacrament of the Evangelical Lutheran Church in America.
- **†S8.12.** As this synod's pastor, the bishop shall:
 - a. Preach, teach, and administer the sacraments in accord with the Confession of Faith of this church.
 - b. Have primary responsibility for the ministry of Word and Sacrament in this synod and its congregations, providing pastoral care and leadership for this synod, its congregations, its ministers of Word and Sacrament, and its ministers of Word and Service.
 - c. Exercise solely this church's power to ordain (or provide for the ordination by another synod bishop of) approved candidates who have received and accepted a properly issued, duly attested letter of call for the office of ministry of Word and Sacrament (and as provided in the bylaws of the Evangelical Lutheran Church in America).
 - d. Ordain (or provide for the ordination of) approved candidates who have received and accepted a properly issued, duly attested letter of call for service as ministers of Word and Service of this church.
 - e. Attest letters of call for persons called to serve congregations in the synod, letters of call for persons called by the Synod Council, and letters of call for persons on the rosters of this synod called by the Church Council.
 - f. Install (or provide for the installation of) rostered ministers whose calls the bishop has attested.
 - g. Exercise leadership in the mission of this church and in so doing:
 - 1) Interpret and advocate the mission and theology of the whole church;
 - 2) Lead in fostering support for and commitment to the mission of this church within this synod;
 - 3) Coordinate the use of the resources available to this synod as it seeks to promote the health of this church's life and witness in the areas served by this synod;
 - 4) Submit a report to each regular meeting of the Synod Assembly concerning the synod's life and work; and
 - 5) Advise and counsel this synod's related institutions and organizations.

h. Practice leadership in strengthening the unity of the Church and in so doing:

- 1) Exercise oversight of the preaching, teaching, and administration of the sacraments within this synod in accord with the Confession of Faith of this church;
- 2) Be responsible for administering the constitutionally established processes for the resolution of controversies and for the discipline of rostered ministers, and congregations of this synod;
- 3) Be the chief ecumenical officer of this synod;
- 4) Be a member of the Conference of Bishops and consult regularly with other synod bishops;
- 5) Foster awareness of other churches throughout the Lutheran world communion and, where appropriate, engage in contact with leaders of those churches;
- 6) Cultivate communion in faith and mission with appropriate Christian judicatory leaders functioning within the territory of this synod; and
- 7) Be *ex officio* a member of the Churchwide Assembly.
