We recognize that we are called to be in good relationship with our neighbors, that the tribes are sovereign nations, that there is a history of broken treaties and broken trust, and that there is lots of work to be done. And we also recognize that as Christians, we have faith in new life, in hope for mending what is broken, and in our calling through the Holy Spirit to do this work.

Reports

Treasurer's Report

Terry Johnson gave a recap of executive committee action in February of closing out the 2023 Mission Plan (Fiscal Year End 01.31.2024) and revising the 2024 Mission Plan (Fiscal Year End 01.31.2025). The 2024 Mission Plan revisions were based on statements of intent from congregations and updated expenses. The executive committee also approved increasing mission support to churchwide from 41% to 42%.

Johnson recapped the endowment year-end financial statements. The 2024 distribution from endowment funds was increased to 5%. Historically it has been at 4%.

Partner Ministries

Heartland Ephphatha - Jason Andera

Jason and his wife have worked with the deaf and hard of hearing for 20 years. They provide service at Peace Lutheran at their 9:00 service. They also work with Church on the Street providing one interpreter through Augustana University. They also provide sign language classes. They are willing to help other congregations. Thank you to the synod for the support.

Bishop's Report

Bishop Constanze reported on the Council of Bishops. Discussed Digital Communion, Extending the Table and Expanding Participation. CLRC - renewed Lutheran Church, asked to review initial documents. Seven subgroups have been asked to come up with a proposal for Churchwide in 2025. 63 congregations raised their mission support. Michael Burk is serving as Bishop Pro Temp. Bishop Eaton is scheduled to return March 18, 2024. The Council of Bishops had intentional learning about our social statement. There are two public statements: Crisis in the Middle East and the Border Crisis. Staff Development is due in 2028. We are doing educational events to get us to 2028. Bound Conscience.

Rev. Renee Splichal Larson

Mobility is similar to last November, but they are different. She is doing monthly SAM calls and interim minister calls. She is also doing monthly Region 3 zoom meetings. She also touched on annual reviews for congregations. The Senior Pastor Retreat had 30-35 participants. The First Call Retreat is May 5-7 with Mark Allen Powell. She is also working on a pilot program with Wartburg.

Rev. Jonathan Vehar

Thank you for this work. Box Elder is experiencing a budget shortfall. New start money is being released in May. \$33,000 has been saved for this purpose. Box Elder is a great place to share the good news of Jesus. Neighbors in Solidarity takes up much of his time. Most are in high poverty areas - pray for them- show up if possible. Stewardship initiative - no one size fits all. He wants to do monthly meetings for different topics.

Vice President's Report

Dennis Thompson went to the Synod VP meeting in Chicago. There is now a 3 year rotation. There were 40 there at Lutheran Center. The VP's are also doing a monthly zoom. They are working to standardize the language between conferences.

Executive Committee Report

Thompson reported out action items that the executive committee has done. Lois Borchardt is now full time with the synod. Gave a \$5,000 grant to Shepherds Table. January was cash management; two grants were given for continuing ed. February closed out FY 2023-24. Revised the 2024 Mission Plan. Grants for Jamie Dupree, Media & technology and Seminary & debt. March approved the 2025 Mission Plan, approved electrical for Woyatan, approved Lilly Grant interest to be used, Funds for continuing ed, any grants under synod id must be approved by synod council.
