#### Call to Order

#### Land Acknowledgement read by Rev. Jonathan Vehar

South Dakota Synod of the Evangelical Lutheran Church in America recognizes that the Oceti Sakowin (the Seven Council Fires of the Lakota, Dakota, Nakota), the Arikara, the Ponca and the Cheyenne, are the historic inhabitants of South Dakota; and South Dakota is the current home of the Cheyenne River Tribe, Crow Creek Tribe, Flandreau Santee Tribe, Lower Brule Tribe, Oglala Tribe, Rosebud Tribe, Sisseton Wahpeton Oyate, Standing Rock Tribe, and Yankton Tribe.

We recognize that we are called to be in good relationship with our neighbors, that the tribes are sovereign nations, that there is a history of broken treaties and broken trust, and that there is lots of work to be done. And we also recognize that as Christians, we have faith in new life, in hope for mending what is broken, and in our calling through the Holy Spirit to do this work.

# **Board Orientation, Development and Education**

The Synod Council was introduced to the Synod Council Board Book which is available in Google Drive.

A new item for the Synod Council is a board covenant. As members of the Synod Council of the South Dakota Synod of the ELCA, we are entrusted with the responsibility of the leadership of our synod. We seek to honor our responsibility through covenants to God; the synod; its congregations and ministries; our churchwide ministries; and to each other. Each synod council member would be asked to read and sign the covenant.

Dennis Thompson discussed the importance of confidentiality. Confidentiality forms were passed out and the members signed and returned the forms.

## **Bishop Election Survey committee**

Rev. Cassandra Lamb discussed the Bishop Election Survey that went out on July 31. The questions are based on the model from churchwide. September 4, 2024 is the end date for surveys to be filled out. Council members are asked to encourage people to fill out the survey. She will give a report on the results at the October meeting.

Constitutions - Rev. Jonathan Vehar explained that constitutions help us offer structure to our mission.

- a. ELCA Constitution
- b. Synod Constitution Congregation Constitution
- c. Structure of the ELCA

Changes at churchwide assembly must also be recognized in our local constitutions. Dennis suggested looking at the bishop election in the constitution.

#### First talk by Victoria Flood, Sr. Director for Mission Support in the ELCA

Victoria had each member answer the question "What is the SD Synod". She also discussed Pew research and explained that a lot has come out after the pandemic.

Council Responsibilities for the Roster - Renee Splichal Larson

Christie Meier discussed SAMs. Council responsibilities for the Roster document is in the Board book. Renee discussed the Roster Management Glossary. Sabbatical is a policy with each congregation. Renewals can be requested for leave from call.

## Shepherd's Table - Rev. Sawyer Vanden Heuvel

Rev. Sawyer gave an overview of Shepherd's Table. It was launched in December of 2023. They meet at the Prism Center. The format is dinner church is a basic service with worship and communion followed by a full meal for all. They have partnered with COTS for a Pride service this spring. They joined at the Multicultural Center and used round tables.

#### Church on the Street - Rev. Chris Matson

This church was built in Sioux Falls for the unhoused or sparsely housed. The idea is taking the gifts of the church out to the people. Currently they worship at Heritage Park on the second Saturday of the month.

# First Lutheran African Ministry

A field trip was planned, but timing didn't work out. Rev. Jonathan Vehar gave a presentation on FLAM. They now worship just off of Kiwanis & 12th Street where they are renting two store fronts. Congregants are basically from Liberia. It is decorated with Liberian flags. Worship is in English. Rev. Jonathan worshiped with them on Father's Day. Challenges are that they were basically formed out of one church. The congregation is basically born out of poverty. Offering goes to rent. They get help from churchwide, Neighbors in Solidarity (NiS) and the synod. Worship is very lively. It is suggested that outside groups, such as confirmation classes, visit and try to form relationships.

Partner & Supported Ministries-Rev. Jonathan Vehar

Rev. Jonathan Vehar listed the different ministries that we currently partner with. He noted that DSU in Madison is looking into Campus Ministry. Box Elder is working to get a mission start and call a Mission Developer. They have met with the Zoning Board. They are filling out paperwork and hope to have it together by the end of the year. Box Elder doesn't have community space to rent.

#### **Pine Ridge Reconciliation Center**

Work is being done to get the Articles of Incorporation finished. The model follows the job corps model. We need the cooperation of the Job Corps.

# **Lutheran Planned Generosity Charter recommendation**

Lutheran Planned Generosity (LPG) operates under the synod's EIN. LPG has its own governing board and separate financial statements. No governing documents have been found.

The LPG board and executive director Kathy McHenry request that the synod council approve the charter for LPG.

#### Remove S9.01.A20 from the SD Synod Constitution

Language was added to the constitution regarding election of synod council members after the 2020 synod assembly was cancelled due to COVID.

MSC to rescind S9301.A20 from the Constitution, Bylaws, and Continuing Resolutions of the synod. SC.2024.08.05

#### Review S7.21.A04 in the SD Synod Constitution

S7.21.A04 in the SD Synod Constitution regards synod assembly voting members. The constitution should be updated to conform to churchwide language defining the term 'youth' and 'young adult'. Language should also be updated to where congregational baptized membership total come from since a South Dakota Synod Handbook is no longer publish.

MSC to amend S7.21.A07 as follows: Any congregation of this synod which elects as a voting member a youth or young adult as defined in the Principals of Organization 16-21 year old as a voting member shall be granted one additional voting member. The term "youth" means a voting member of a congregation who has not reached the age of 18 at the time of election or appointment for service.

The term "young adult" means a voting member of a congregation between the ages of 18 and 30 at the time of election or appointment for service. Any congregation of this synod which elects a person of color and/or a person whose primary language is other than English as a voting member shall also be granted one additional voting member. The number of lay voting members per congregation is determined by the following scale: (table inserted)

Figures used are the published baptized membership totals from the most recent South Dakota Synod Handbook most recently reported by congregations through the annual Parochial Reports.
